

California Proposition 65 - Clear and Reasonable Warning Policy & Notice to Distributors and Vendors

Officially known as the Safe Drinking Water and Toxic Enforcement Act of 1986, California Proposition 65 requires businesses to warn Californians when exposure to toxic chemicals known to the state may cause cancer, birth defects, or other reproductive harm, pursuant to California Health and Safety Code section 25249.5 seq. ("Proposition 65") and 27 CCR § 25600.2(b) (effective 30 August 2018).

The agency charged with administering Proposition 65 has promulgated new regulations governing these warnings, which go into effect on August 30, 2018. In addition to providing new "safe harbor" warning language for retail sales of products creating exposures to a listed chemical, the new regulations also explicitly require warnings to appear in catalogs and on e-commerce sites. These warnings must be "clear and reasonable," and must be provided to consumers in California prior to purchase.

G. F. Lasswell Co., Inc. does not manufacture any products. Our suppliers are required to meet all federal, state, and local laws, regulations and ordinances including California Proposition 65 warnings. G. F. Lasswell's expectation is that our Suppliers know what is in their product(s); disclose products requiring Proposition 65 warnings and apply any required labeling, and execute accordingly including any KleenWell® branded product(s).

G. F. Lasswell Co., Inc. stocked products are distributed as provided by the supplier. For existing stock that requires Proposition 65 labeling (as identified by the supplier), additional warning labels are requested with affixing instructions from the supplier.

To ensure G. F. Lasswell Co., Inc. systems and online catalogs reference Proposition 65 warnings for stocked items, G. F. Lasswell Co., Inc. submits annual requests to manufacturers and suppliers to provide a list of products requiring Proposition 65 warnings, warning type, and revised product literature (where typically provided).

Due to the use of Proposition 65 Substances in some of the products we distribute, the following warning label examples will appear on applicable product(s), as directed by the manufacturer.

Warning Label Examples

There are two series of warning labels – long form and short form. The long form requires specifying one or more chemical. The short form simply requires the disclosure of the harm that might occur to a user.

One can use either set, but for our industry's needs, the short form should work best for most.
